President's Letter



Probably no event since Pearl Harbor has affected the outlook of the American people to the extent of those events on September 11, 2001. Terrorism has a depth of evil unmatched in most conventional wars. For Americans, that depth is related to the effect on our homes, our families, our personal safety, our freedom to travel and our peace of mind. Terrorists, if they could, would restrict our freedoms under the Bill of Rights such as speech, religion, press and assembly. The President says that this attack is a declaration of war and the Presidency and the Congress are viewing it in that way.

The importance and value of having constitutional scholars teaching in our secondary school social studies classrooms has never been greater. Education Programs

James Madison Fellowships

Fellowship awards constitute the core of the Foundation's programs. The Foundation conducts an annual nationwide competition to select James Madison Fellows. Fellows are selected for their academic achievements and for their desire to be more knowledgeable secondary school teachers of social studies and American history and government.

Fellows must have demonstrated an interest in pursuing a course of graduate study which emphasizes the Constitution and Bill of Rights and have demonstrated a willingness to devote themselves to teaching and to civic responsibility. The Foundation annually selects at least one James Madison Fellow from each state, the District of Columbia, and the Commonwealth of Puerto Rico, and considered as a single entity, Guam, the Virgin Islands, American Samoa, the Trust Territories of the Pacific Islands, and the Commonwealth of the Northern Marianas in which there are at least two resident applicants who meet the minimum criteria. An independent review committee appointed by the Foundation evaluates all valid applications and recommends to the Foundation, for appointment as James Madison Fellows, at least one outstanding applicant from each state. James Madison Fellowships are awarded to master's degree candidates as follows:

Junior Fellowships are awarded to college seniors and graduates who wish to become secondary school teachers of American history,

American government, or social studies for full-time graduate study toward a master's degree. Junior Fellows are eligible for a maximum stipend of up to \$24,000 prorated over the period of study. In no case can the stipend exceed \$12,000 for each year of study.

James Madison

Senior Fellowships are awarded to experienced secondary school teachers for part-time graduate study toward a master's degree during summer session or in evening and weekend programs. Financial support for Senior Fellows is limited to five calendar years and up to a maximum stipend of \$24,000 prorated over the period of study.

Fellowship recipients may attend any accredited university in the United States with a master's degree program offering courses or training that emphasize the origins, principles, and development of the Constitution and its comparison with constitutions and histories of other forms of government. The Foundation reviews each Fellow's proposed course of study for an appropriate balance of constitutional subject matter and other courses based on the Fellow's goals and background.

All James Madison Fellows must agree to teach full time in secondary school for at least one year for each year of assistance. If this requirement is not met, the recipient must reimburse the Foundation for all financial assistance plus interest. The Foundation strongly encourages Fellows to teach in their home states when they complete their education.

2001 Summer Institute on the Constitution

The 2001 Summer Institute on the Constitution was held from July 2, 2001 to July 27, 2001. A total of 54 James Madison Fellows, representing nearly every state, attended the Institute. One of the participants came from Havana, Cuba.

The Institute took place on the campus of Georgetown University and was the seventh annual Institute held by the Foundation. This was fifth Institute held at Georgetown University. Georgetown University awarded six graduate credits to each participant.

The Foundation created the Summer Institute program to assure that each James Madison Fellow had a solid grounding in the history, framing, ratification and principles of the U.S. Constitution. It is intended that each Fellow will take this newfound knowledge into his or her classroom.

The course offered at the Institute was History 520-10, "Foundations of American Constitutionalism." The course examined in depth the intellectual, cultural, social, and political context of the creation of constitutional government in the American colonies and in the American Republic during and after the Revolution. The course blended perspectives of history and political science as participating Fellows engaged in close study of contemporary source materials such as the debates in the Constitutional Convention, The Federalist, and Antifederalist writings, as well as the best current scholarship on the subject. (The 2001 syllabus is attached).

Each academic day began with a one and one half-hour lecture given by one of the four Institute professors. Following the lecture and a brief break, the group divided into four discussion groups where the daily assigned readings were examined in detail. Following the discussion

groups, everyone rejoined to have lunch in a private dining room. During lunch, informal discussion continued between the Fellows and the professors.

The Institute included tours of historic sites associated with the founding period, specifically Mt. Vernon, Monticello, and Montpelier. Course lectures were given at these sites. One day was spent at the Supreme Court where Associate Justice Anthony Kennedy addressed the Fellows about the Supreme Court and the judiciary. Professor Edward Smith of the American University gave special tours of Arlington Cemetery, the African American Presence in Washington, D.C., and Capitol Hill.

The Fellow's academic progress was evaluated through three written examinations. Fellows were also evaluated on class participation. Every participant in the 2001 Institute completed the course successfully.

The Foundation staff handled all administrative aspects of the Institute including working with the University on housing and food services. Additionally, the staff worked with individual Fellows in handling personal issues that may have arisen.

The course was directed and taught by Dr. Herman Belz, the Foundation's Academic Advisor and Professor of History at the University of Maryland and Adjunct Professor of History at Georgetown University. Dr. Whitman H. Ridgway, Associate Professor of History at the University of Maryland, and Dr. Jerome Hanus, a Professor of Political Science at the American University assisted Dr. Belz. The seats held by Professor Ridgeway and Professor Hanus are endowed by the Atlantic Foundation. The fourth professor (and new to the Foundation) was Dr. Suzette Hemberger, an independent scholar.

2001 James Madison Symposium

The annual James Madison Symposium is held so that James Madison Fellows can further their scholarship on the Constitution and renew acquaintances in the process. The 2001 Symposium was held on July 16, 2001 in the Hart Senate Office Building on Capitol Hill. The topic of the 2001 Symposium was "Reading Madison's Mind."

The Foundation invited Professor Jack Rakove of Stanford University to lecture on this subject. Professor Rakove gave a 30 minute lecture, followed by a response delivered by Professor Rosemarie Zagarri of George Mason University. Dr. Herman Belz, the Foundation's Academic Advisor acted as moderator. Professor Belz invited questions to the



panel from the audience. Following the Symposium, the Foundation hosted a reception.

The Symposium was attended by all of the James Madison Fellows participating in the 2001 Summer Institute. In addition, a large number of alumni Fellows traveled to Washington, D.C. for the Symposium. Faculty members of local university history departments and congressional staff members were also in attendance.

Development

The Foundation is currently able, through income from its endowment and from gifts received or promised, to offer at least one domestic fellowship in each state perpetually. It is the desire of the Foundation's board to award a minimum of two fellowships in each state annually. The Foundation has now begun to implement this plan in the most populous states.

Since the Foundation endowment covers all overhead and administrative costs, each donation to the Foundation is devoted solely and directly to funding the graduate study of experienced and aspiring teachers. Donations may be directed to the support of fellowships in particular states or for fellowships in a national pool--all of which are selected according to the consistent criteria and standards governing the Foundation's selection process.

Note 1: The Foundation has an estimated funding commitment of \$4,452,000 to support the 371 fellowships that have been awarded. The recipients of these fellowships are currently taking graduate course work.

Note 2: An independent, not-for-profit organization, The James Madison Education Fund, Inc. provides additional financial support for the education programs of the Foundation. The total assets of the Fund on September 30, 2001 were \$5,459,371. This includes a 2001 program grant of \$1million from the Foundation Trust.

Note 3: The private gifts to the James Madison Education Fund during the period were \$289,234.

Note 4: Equity amounts reflect adjustments made by our GSA accountants and to reflect a grant to the James Madison Education Fund of \$5 million in FY00.

Governance

The Foundation is governed by a Board of Trustees consisting of thirteen members. Twelve--two members of the Senate, two members of the House of Representatives, two members of the federal judiciary, one governor, two members of the general public and three members of the academic community--are appointed for six-year terms by the President of the United States. The Secretary of Education serves as an ex officio member. With the exception of the federal judges and Secretary of Education, board membership is evenly divided between political parties.
